# Combatting Counterfeits

VeriLite is compatible with **all National Systems** and markets across Europe. To fulfil the needs of our international customers we ensure that it supports all major European languages. It also runs on the same public cloud platform used to host the European Hub and the Solidsoft Reply national systems.

After purchasing the license, VeriLite will be ready in 3 simple steps:

1. Connect your own barcode reader to your PC or Tablet.
2. Choose your favourite browser to connect automatically to your National Medicines Verification System.
3. Use VeriLite to perform all the operations necessary to meet the legal requirements of the FMD.

## FMD and the EMVS

The **Falsified Medicines Directive (FMD)** was implemented to prevent counterfeit drugs in Europe's supply chain. It requires manufacturers to add safety features like unique barcodes and tamper-evident seals, ensuring patients receive authentic medications. In response to the global risk of falsified medicines, the **European Medicines Verification System (EMVS)** identifies over 10 billion medicine packs annually, safeguarding public health.



# What is VeriLite

VeriLite is Solidsoft Reply's **seamless, GSI-certified, cloud-based online solution** that simplifies medicine verification and dispensing, and enhances compliance with the FMD (EU Falsified Medicines Directive).

Whether you are a **wholesaler** responsible for distribution, a **pharmacist** or a **doctor** responsible for dispensing medicines, VeriLite provides an easy solution enabling you to meet the regulatory requirements of the FMD.

## VeriLite enables you to:

- Verify packs.
- Dispense packs.
- Update a pack's status e.g. destroyed, sample, free sample\*, stolen\*, or locked\*.
- Reactivate a pack if required\*.
- Mark packs as exported if they have been sold outside the EU.

\*Certain actions are only applicable to wholesalers

**This solution covers the supply chain from manufacturers to patients, providing end-to-end visibility, authentication, verification, and data analysis.**

Leveraging interoperability, this web-based solution works on major browsers like Google Chrome, Edge, and Firefox, with no plug-ins, software installation, or specific hardware requirements, ensuring a hassle-free experience.

VeriLite operates in multiple modes, including **“Multiple Mode”**, where users can scan packs sequentially to create an on-screen list. It tracks unique codes, alerts users to duplicates and submits the list to the NMVS for asynchronous processing, with results returned to VeriLite upon completion.

# Reach and compatibility



## Scanners Compatible with VeriLite

Designed to work with **the widest range of commonly-available barcode scanners**. The barcode scanner must meet the following three criteria to work effectively with VeriLite:

- It must be able to read **Data Matrix EC200 two-dimensional barcodes**.
- It must be configured to **operate in keyboard or numeric keypad mode**. Many scanners are configured to do this by default.
- It must correctly **represent the data in GSI-encoded barcodes** while operating in keyboard or numeric keypad mode. Most scanners support this, but you may wish to check with the manufacturer.

Reports are user-tailored, with exportable features, including a wholesaler list and product catalogue for your National System.



## Operating Modes for Every User

VeriLite accepts product scans in a variety of different entry modes to allow you to tailor your processes with freedom, including offline and multiple entry modes.



## Secure Data Repository

The unique identifiers (UIs) and the associated data and events for each medicine pack or unit are stored and verified.



## Tailored Permissions

Differentiates between administrators, who manage accounts and users, whose NMVS-determined permissions vary by market (e.g., wholesalers may or may not dispense packs).



## Notification Alerts

Users will receive alerts about potential falsified medicines. VeriLite also alerts pharmacies and wholesalers of expired, withdrawn, or stolen medicines.



## Future-Ready, Installation-Free

Delivered via the cloud, VeriLite requires no installation and continually evolves to stay aligned with the FMD and technology advancements.
